Introduction of the Host City: Seoul



Serving as the capital city for several kingdoms and dynasties in different historical periods, Seoul continues to thrive as the center of Korea to this day. Seoul is a beautiful and dynamic city where culture and history live in harmony with its people.

As the economic and cultural center of Korea, Seoul has extensive experience in hosting large-scale international events such as the 1988 Seoul Summer Olympics, 2002 FIFA World Cup, 2010 Seoul G-20 Summit, 2020 Seoul Smart City Leaders Forum, and many more.



During her speech, Maimunah Mohd Sharif congratulated WeGO on its achievements in the first decade and recognized WeGO's strong commitment to assist the digital transformation of cities. She also accentuated the significance of creating people-centered smart cities that promote inclusiveness and protect human rights. She pointed out that the COVID-19 pandemic has accelerated digitalization, while simultaneously increasing the digital divide and inequality, which cities must take into account when promoting the transformation into smart cities. In doing so, she believes that WeGO's vision of creating "Smart Sustainable Cities for All", making use of digital technology to improve the quality of life for all urban residents, while ensuring long-term economic, social and environmental sustainability has never been more important. To achieve this goal, she laid emphasis on partnership, specifically in working together with other international organizations such as WeGO to collaboratively work towards these goals.

4th WeGO Awards Ceremony

About the 4th WeGO Awards

Established in 2011, the WeGO Awards is WeGO's triennial competition that recognizes and promotes local governments with exemplary projects and solutions that use ICT to improve the quality of life of citizens. The 4th WeGO Awards were held on Feb-Sep 2020. Local governments competed with their projects in the following categories: Efficient Government, Emerging Technology, Mobility, Open and Inclusive city, Safe City, and Sustainable City.

The top two submissions in each of the six categories are awarded the Gold Award and Silver Award, respectively. As WeGO received a good number of exceptional applications, it was determined that a Special Mention Award be awarded in each category. Out of the 52 applications from 18 countries around the world—the majority from Asia-Pacific and Latin America—18 were selected by the judges as winners.

Agenda 1: Reporting of the EXCOM Meeting

The General Assembly reported on the WeGO Executive Committee (EXCOM) Meeting 2021, which was hosted by Seoul, the President City of WeGO, online on October 14, 2021 (Thursday) with the presence of 10 EXCOM member cities. Several important agendas were discussed during the meeting and were summarised as follows:

- The EXCOM conducted the annual assessment of the WeGO Regional Offices, shared recommendations for improvement and approved continuation of five Region Offices' operations for the next year.
- The EXCOM selected Kampala, Uganda as the host city of the EXCOM Meeting 2022.
- The EXCOM introduced differentiated services based on membership fee payment status and incentives to members with good membership records.
- The EXCOM approved five new members this year, contributing to a total number of 213 members. Since the last General Assembly in Ulyanovsk in 2017, 93 members have joined WeGO.

Agenda 2: Reporting of the WeGO 2030 Masterplan

The General Assembly approved the WeGO 2030 Masterplan, which displays a clear vision to strengthen WeGO's ambitions and sets out how they will be achieved.

To become the world's foremost sustainable cities organization, WeGO will take the following action plans, according to the WeGO 2030 Masterplan:

- Strengthen benefits and services to members
- Promote digital transformation of WeGO's programs and services
- Focus on geographical and sectoral growth
- Build citizen-centric smart cities
- Strengthen financial resources

Agenda 3: Approval of the WeGO Statutes Amendments

The General Assembly approved amendments made to the WeGO Statutes to align with the newly approved WeGO 2030 Masterplan. The summary of amendments are as follows:

- Revised terms limiting WeGO's scope of cooperation within cities to stay current with the organization's evolving set of aims by including broadened partnership of local governments, corporations, and institutions.
- Renamed the Friendship member category as Institutional member to distinguish the types of subject to the membership.
- Added a new article to enable remit, reduce and or commute either for any period of time or otherwise the annual fee payable by any member for the purpose of alleviating economic and financial hardship to any members for the purpose of rectifying any anomaly.
- Adjusted the membership fee scale for all three categories (local government, institutions, corporates) to align member's financial capacity with a special consideration to less populated cities and start-ups.
- Added new articles to welcome the Co-Presidency framework.



Summary

The WeGO Executive Committee (EXCOM) Meeting 2021 was hosted by Seoul, the President City of WeGO, online on October 14, 2021 (Thursday) with a total of 10 EXCOM Members attending the meeting.

Agenda 1: Review of 2021 WeGO Secretariat Annual Report

The EXCOM reviewed the 2020-2021 annual report presentation made by the Head of the Program Department at WeGO (Ms. Eunbyul Elena Cho). The presentation expanded on WeGO's activities held in 2021, including digital services, capacity build programs, regional networks, briefing sessions and governance meetings. She also elaborated on WeGO's future activities such as workshops for the Africa Smart City Network (AFSCN) and Latin America Smart Cities Network (LASCN) as well as programs with our regional offices, including Chengdu and Beyoğlu. The Chair applauded the Secretariat for pursuing various activities that aimed to assist members in achieving digital transformation to a smart city.

Agenda 2: Review of 2021 Financial Report & Strategy

The EXCOM reviewed the report on WeGO'S financial support and expenses for projects and programs, including the contributions from the President City, Seoul, and use of membership fees, and its expenditures for the past year as well as the current balance.

Membership fee revenue has been increasing until 2019, however due to the COVID-19 pandemic, ongoing throughout 2020 and 2021, membership fee collection has suffered because of the financial difficulties that regional governments, corporations and institutions are facing all over the world.

To acknowledge the financial difficulties WeGO members are facing, WeGO has begun implementing a Financial Reinforcement Plan, which aims to improve internal administrative procedures regarding membership application, introduce differentiated benefits to members with good payment records, and revise the WeGO Statutes to tailor membership fee amounts for local governments, corporations, and





institutions. Altogether, the organization wishes to ensure the financial stability of the organization and to reduce WeGO's dependency from contributions made by the President City.

As the President City of the organization, the Chair embraced the fiscal reinforcement plan.

Agenda 3: Review of Differentiated services based on membership fee payment status and incentives to members with good membership records

The EXCOM reviewed a new initiative that was proposed to differentiate services and opportunities for members with a history of activeness and good payment record.

With such an initiative, a points-based ranking system, indicated below, has been introduced to the members.

As the President City, Seoul will elect the Vice President City among the six cities that were nominated by the EXCOM at the 5th General Assembly, including Beyoğlu (Turkey), Chengdu (China), Makati City (the Philippines), Mexico City (Mexico), Moscow (Russia), and Seberang Perai (Malaysia).

Seventeen EXCOM candidates have been listed for the term 2021 to 2023, including Abuja (Nigeria), Beyoğlu (Turkey), Chengdu (China), Dhulikhel (Nepal), Hebron (Palestine), Kampala (Uganda), Makati City (Philippines), Maputo (Mozambique), Mexico City (Mexico), Moscow (Russia), São Paulo (Brazil), Seberang Perai (Malaysia), Seongnam City (Korea), Seoul (Korea), Ulaanbaatar (Mongolia), Ulyanovsk Region (Russia), and Wellington (New Zealand).
